## Summary of your complaint

Please give further information about your complaint.  
After fully explaining to Dr. Anand Trip in explicit detail that I am in asylum (immigration proceeding) in the United Kingdom due to repeated instances of criminal malice in medical settings (about 50 instances of criminal fraud and criminal negligence) with the intent of causing physical harm or neurological disfigurement Dr. Trip with the help of Dr. Santiago Catania replicates the same type of medical fraud that had taken place leading to asylum. Dr. Trip orders tests for Multiple Sclerosis; evoked potential tests (VEP, SEP) and electroencephalogram (EEG). Dr. Catania responds to the complaint about the VEP, SEP. In the frame of the overall case (50 instances of negligence) the intent is clear and explained here. Dr. Catania ignores signs of neurodegeneration in nerve conduction tests in the upper and lower limbs (cervical and lower spine). The clinical aberration is clear malformed graphs of the upper and lower limb SEP tests of the left hemisphere that indicate neurodegeneration and his statement is a clear mis statement even after he has a chance to rectify his error in the hospital complaint. His attempt is similar to past fraud leading to asylum in the United Kingdom. The medical report was to try and not acknowledge the past negligence and criminal malice that had taken place prior to getting to the UK by hiding signs of neurodegeneration. The features of neurodegeneration are clear in the diagnostic data (they couldn't be any clearer) and correlate perfectly with MRI data and statements by other diagnosticians. The MRIs show gross neurodegeneration. When I received the report I immediately canceled all the remaining diagnostics considering intent (MRIs, EEG, LP, and eye tests (most done before)). I recognize when a diagnostician tries to hide negligence due to past situations. Dr. Catania and Dr. Trip would be accomplice to the same situation of clinical fraud and malice that instigated asylum in the UK. They are furthering criminality.

The Parliamentary and Health Service Ombudsman has the complaint but they haven't reviewed it and haven't assigned a case worker yet; they stated they would but the complaint is outside the Ombudsman's and NHS's role since its part of a larger criminal case. Since the case is part of a multinational criminal fraud and criminal negligence case it was reported to the police who then informed me that due to the complexity of the criminal medical fraud and medical negligence it would have to be reported through the General Medical Counsel (GMC) who could then conscript the police. Its falls outside the role of a the NHS and Ombudsman because the medical falsifications are with the intent of effecting a person in asylum in the United Kingdom for the same reason; repeating medical diagnostic fraud to hide a disease pathology or to mis portray it.
