

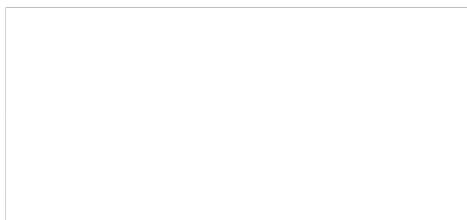

Dr. Anand Trip and Dr. S. Catania in National Hospital of Neurology and Neurosurgery, Queens Square make misstatements in diagnostics to try and hide the neurological damage caused by negligence perpetuated by the United States in the past.

After consulting with Dr. Anand Trip in the National Hospital for Neurology and Neurosurgery in Queens Square, London on the 29th of August, Dr. Trip ordered typical tests for Multiple Sclerosis. A VEP (visual evoked potential), SEP (sensory evoked potential), EEG(electroencephalogram), LP(lumbar puncture), and MRI (of brain and spine with contrast).

I explained my clinical history and the progression of MS along with recent therapies abroad (IV Rituximab) and Dr. Trip is informed that I am in asylum in England due to the repeated instances of medical negligence and fraud to cause intentional physical harm in a medical settings that took place in the US and abroad. My objective was to not replicate the same situation; the hospital replicates the same situation in a clear way.

The first of the set of diagnostic tests takes place on the 18th of September, which includes a Visual Evoked Potential(VEP), a Somatosensory Evoked Potential (SEP), and a Electroencephalogram (EEG). Of the three tests the conclusions from the SEP test are grossly misstated. The reports for the diagnostics are given below and the summary from Dr. Trip is included (after the diagnostics) though he simply ordered the tests. This is the same situation as in the past.

I believe the neurophysiologist would be responsible for this test, as stated in the report, Dr. S. Catania and his two clinical physiologists Ms. J. Oliveira and Mr. P. Fernandes.

I placed a complaint with the hospital and receive a letter dated November 26th 2019 where Dr. S. Catania still persists in supporting the falsified test results.

The clear intent is to withhold medications for the disease (multiple sclerosis), which in turn will cause physical harm. Due to my history in this case it easy to see the intent by these clinicians and how I recognized it.

There is also a emergency department room letter denial of typical emergency response for multiple sclerosis attached in the next page. It shows the general pattern of lack of medical help in emergency situations even in the UK for multiple sclerosis.

The entire course of events and communications with the doctor (Dr. Anand Trip), diagnostician (Dr. S. Catania) and the hospital complaints department are included here.
