Hello Mr. Cooke,

The situation with Case # 2302885/20 has escalated to assault with the perpetrator (Dr. Anand Trip) directing other doctors in Addenbrookes Hospital, Cambridge on April 13th and 14th 2020 to perpetuate assault on the victim by withholding medical treatment is sever and gross presentation in an attempt to not admit to dincial fraud.

The doctor (Dr. Anand Trip) and diagnostician (Dr. S. Catania) are accomplices to felony in a much larger criminal case (that resulted in asylum in the UK). The doctor and diagnostician are aiding and abetting other doctors abroad (the case is multinational) in criminal medical fraud for medical negligence case with the intent of physical harm, physical disfigurement, or intentional disability through negligence. Its criminal due to intent of physical harm and actualization of physical harm.
