Hello Dr. Vogeler,

I could send the digital copy of the documents by mail immediately (USB drive) and then we could catch up in person or by Skype later.

For an in person meeting, as of right now I have freedom to move between England and Germany but I may have an immigration restriction soon (probably within the next two weeks) that would restrict me to not leave the UK for a period of 6 months, which makes the person to person meeting difficult in the short term.

If we were to do an in person meeting, it would have to be soon.

The USB would include my entire pertinent medical record, the Charity Hospital data, the Bundeswehrkrankenhaus data and examples in other instances of fraud taking place (this isn't an isolated instance in my case, some of it is explicit evidence of fraud taking place; eg. a video of a radiologist erasing MRI series images to try and fraudilate MRI reports). The documents are all PDF searchable so it would take little time to reference them.

For this specific case (the 2 ER appointments and the LP lab results) its only about 20 pages of hospital reports that I extracted from Charity Hospital (and that's the entire medical record so you wouldn't have to extract anymore data from the hospital).

The other medical records to negate the Charity case are far more extensive.
