Was ist passiert, warum ist es passiert?

Hello Berlin Police,

I am filing three different related police cases in Berlin in a single posting:

1. The first is clinical assault that took place between March 11th and March 17th 2018 in Charity Hospital Mitte and Charity Hospital Virchow:

2. The second is medical fraud in Labor Berlin (which is part of Charity Hospital) for a lumbar puncture test ordered/completed by Dr. Daniela Bermphol in Charity Hospital. The fraudulent medical test was used to assault the patient on March 11th and March 16th to March 17th in Charity Hospital Emergency Room.

3. There is another related police report that could be filed but it takes place outside of Berlin, in Riga, Latvia also pertaining to medical radiology fraud. Details are given in this link:

Withholding medication to intentionally harm the patient in the first posting is assault in a clinical setting. Citing fraudulent lab reports and making false medical statements using fraudulent lab reports makes it a criminal form of clinical assault.

Making fraudulent statements in clinical reports about MRIs where the MRIs have clear evidence of radiological fraud and replicating the radiological fraud makes it a criminal matter as well.

The reason for the filing now is repeated instances of assault by clinicians since to harm the patient (the most recent being April 11th to April 14th 2020); Its the same assault in a different location thus extending the significance of past instances of assault.

The clinician in Berlin Charity Hospital on March 16th 2018 (Dr. Pia Schumacher) indicated his intent in harm and his method to cause harm in his recorded conversation and while citing a falsified (clinically fraudulent) laboratory test completed in Charity Hospital as the reason to withhold medications in the clinical setting. Most of Dr. Pias statements are a direct indication of intent in assault and object in perpetuating assault. He explains his reasoning in detail in his recorded conversation in the link below. He is fully aware that the both his clinical statements about MRIs and that the lumbar puncture test results done in Charity Hospital are false. The link below gives full detail of the situation:

As the Dr. Pia Schumacher stated in summation: your condition isnt productive in causing lesions (neurological damage, to physical disability) thus he withheld medications. The patient (me) has a progressive form of MS (where the condition persistently causes lesions).

In multiple sclerosis inflammatory lesions are formed continuously and some turn into permanent lesions (permanent damage), the process of which is prevented with medications (Dr. Schumacher tries to play with the basis of MS in a illogical way as demonstrated in the link).

By withholding medication the clinician is knowingly trying to cause lesions (neurological damage) to further the progression of the condition. Thus he is trying to physically harm the patient. Medications are given in emergency room settings to prevent the formation of lesions that cause disability.

I (the patient) has and had progressive multiple sclerosis during the period of time I was in the ER/Ward setting in Berlin, substantiated by other doctors and MRI findings. I was in severe physical pain and partial difficultly in mobility when I was in Charity Hospital ER and yet Dr. Pia Schumacher and the ward doctors (one of whom was Dr. Kaspar Streitberger in the third medical report) falsified their clinical statements and tests.

Dr. Pia Schumacher cites Dr. Daniela Bermphols clinically fraudulent test (done in the same hospital through Labor Berlin) to withhold medications to harm the patient. The entire situation in the ER/Wardroom setting is described in the link given including the hospital reports, the recorded conversations with the clinicians, and an explanation of how the laboratory test in falsified in this medical setting in detail.

After Dr. Pia Suchumacher and the ward doctors in Charity Hospital denied medications using fraudulent clinical tests I went to Bundeswehrkenhaus, Berlin (the military hospital) on March 17th where they immediately identified the clinical condition, assessed the MRIs appropriately and gave the medications. Their reports and clinical presentation are given in the link.

The IV medication improved the clinical condition by 5 IVs over 5 days done outpatient. 3 IVs were done under Dr. med. Stefenie Klaffke. Dr. Klaffkes report is also given in the link, which inadvertently typifies the clear clinical fraud of Dr. Daniel Bermphol. She seconds that I do have a progressive form of Multiple Slerosis.

Dr. Klaffke was a long term treating neurologist thereafter.

Evidence of the recent assault (April 11th to 14th 2020) is also given to show how the Berlin clinicians used a falsified test to try and intentionally harm the patient in the past in Charity Berlin. The clinical condition progressed due to clinical fraud by Dr. Bermphol.

The patient (me) is in asylum in a foreign nation partially due to these clinicians (legal protection from harm through UN regulated laws). The object of the clinicians was to cause either physical harm or intellectual disfigurement to support clinical fraud in past settings; its perpetuated clinical fraud to harm. Which is why there is another situation of assault in a clinical setting from April 11th to April 14th 2020. Each instance of clinical assault further extends the significance of past instances of assault in clinical settings.
