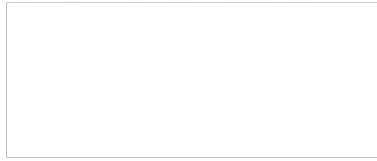


Narendra Jana



I am filing a report for fraud in a medical setting in the UK to try and perpetuate medical negligence (by hiding a disease pathology) in a person escaping the same situation of criminal fraud requiring asylum (immigration status through the Home Office) in the UK. This a repeated situation where a medical professional or a diagnostician tries to fake a medical test in order to withhold medical treatment in a hospital setting, thus harming a patient in a medical setting by doing so. The medical falsifications are intentional thus they are criminal (fraud in medical settings with intent to cause harm, which is similar to former settings that required asylum in the UK). This case is upheld up former and easy to demonstrate instances of criminal fraud and malice in other medical institutions (the full listing of former instances are given below). The doctor in this institution would be accomplice to the same perpetuated crime (effecting asylum status in the patient). Same pattern and same easy to demonstrate intent by the clinician. The filing is against Dr. Dr Anand Trip, the head clinician who order the test, and Dr S. Catania, who's neurophysiology department is responsible for the falsified test. The crime takes place is The National Hospital for Neurology and Neurosurgery, Queen Square, London, WC1N 2BG.

The attached documents describe the course of events that would that would require a filing of a criminal case against the doctor, diagnostician, and hospital.

The following list gives the number of instances of criminal fraud in medical settings that have taken place in the past where this instance would be the most recent event (in the UK). The former instances were directed by US Citizens and clinicians in an attempt to harm me though mistreatment in medical settings (malice and physical harm through medicine). This required

asylum (immigration status) in the UK. The current instance is at the end of the list and highlighted in blue.

Background:

US Citizen – Raised in Massachusetts

34 Years Old

College Graduate with an Electrical Engineering Degree Computer and Information Technology Engineer

Multiple Sclerosis since clinical toxicological syndrome in 2008 and clear neurological signs before in 2007.

Nature of the crime:

The criminals feel that as long as they continue to accumulate medical falsifications (and often unrealistically and dumbly) in a progressive neurodegenerative condition (that often requires hospitalization) they could be absolved of their criminal negligence with further criminal falsifications. The overall effect is that it caused progressive neurological damage to the optic nerves, brain, and spinal column (which is easy to demonstrate in MRIs).

Each instance of criminal fraud is an addition instance of aiding and abetting a criminal to further negligence.

Their mindset is similar to common criminals, an attempt at avoidance of the illegality of criminal fraud by further perpetuating criminal fraud in another setting. They believe it's a convincing crime when its easy to show otherwise as well.

Each instance of fraud is typified in this report as what could only be described as delusional behavior on the part of those committing a crime.

A instance by instance list of criminal medical fraud and criminal medical negligence supported by fraud is given below (its non trivial criminal malice in a medical settings):

1. *2008 April to 2010 October
 - Dr. Richard Falzone – McLean's Hospital, Belmont, Massachusetts, USA
 - Criminal Negligence →
 - Negligence and mistreatment under psychiatry.
2. *2008 and Early 2009
 - Dr. Evan Murray - Belmont, Massachusetts, USA
 - Criminal Negligence →
 - Dr. Evan Murrays negligence followed by Dr. Bruce Price and medically inappropriate recommendations that cause gross

neurological damage, brain lesions and persistent seizures which is attempted to be hidden.

- 2008 December Gross Features of MS Present and ignored in medical settings and intentionally left untreated.
3. *2007 to 2011
 - Dr. Gary Trey – Beth Israel Hospital, Boston, Massachusetts, USA
 - Evasiveness
 - Dr. Gary Trey was my primary care physician (GP) at Beth Israel Hospital. He either never wrote appointment summaries or erased them.
 4. 2009 April 8th April 10th and April 10th
 - Mayo Clinic in Florida
 - Dr. Gary Glicksteen and Dr. Elizabeth Shuster
 - Clear Negligence and Probable fraud
 - The clinicians ignore a gross feature of inflammation in the MRI and try to downplay the grossness of the feature in a MRI series in a clear medical pathology. The clinician, Dr. Gary Glicksteen also hints that he knows its multiple sclerosis in the report but doesn't do the required tests for it. The diagnosticians ignore the recommendations.
 5. *2010 February, 22nd
 - Beth Israel Hospital Radiology - Boston, Massachusetts, USA
 - Criminal Fraud →
 - MRI images are erased to hide MS with a fraudilated MRI report.
 6. *2010 March 15th
 - Dr. Ellen Salurand – UMass Memorial Hospital – Worcester, MA
 - Criminal Negligence →
 - Dr. Ellen Salurand denies treatment under toxicology with clear features in an MRI. All future MRIs show the toxicity that was attempted to be hidden in the February, 22nd MRI. MRI reports are falsified.
 7. *2010 August 25th
 - Dr. Evan Murray and Dr. Steven Siner
 - Criminal Malice in a Medical Setting →
 - Giving ECT (A doctor knowingly giving a patient ECT (electro convulsion therapy) to patient with multiple sclerosis.
 8. 2011 March, 10th
 - Dr. Sundeep Kumar – Beth Israel Hospital – Boston, MA
 - Negligence →
 - Should have recognized that the previous MRI had missing MRI images in an incomplete series. An EEG was done in the hospital that may not reflect clinical presentation.
 9. 2012 July 20th

- Dr. Brad Baker – Worcester, MA
 - Ignored clear optic neuropathy secondary to MS in high resolution images.
- 10. 2012 September 5th
 - Dr. Joel Herskowitz
 - Negligence →
 - Failed to recognize the clear signs of MS and do the appropriate tests.
- 11. 2012 October 30th and December, 27th 2012
 - Dr. Georgia Montouris - Boston Medical Center – Boston, MA
 - Criminal Fraud →
 - Fraudulated EEG and MRIs Reports under Dr. Georgia Montouris - Report it different from what the EEG and MRI shows
- 12. 2013 October 10th
 - Dr. Diana Apetauerova - in Lahey Hospital Massachusetts – Burling Hospital
 - Fraud →
 - MRI Done in Lahey Hospital Massachusetts – Falsified Radiology Report
- 13. 2013 November 8th
 - Dr. Stefanos Kales - Cambridge Health Alliance – Cambridge, Massachusetts
 - Criminal Negligence →
 - Replicates the same medical negligence as Dr. Ellen Salurand, denying treatment for a toxicological underpinning to neurodegenerative condition.
- 14. 2013 November 13th
 - Dr. Sean Rhyee – Umass Memorial – Marlborough, Massachusetts
 - Criminal Negligence →
 - Dr. Sean Rhyee is far more aggressive about limiting treating under toxicology, all MRIs since 2008 show a T1 intensity in the basal ganglia of the brain indicating that the toxicity has be persistent since the first feature. It was an attempt under medicine to cause harm by limiting medical treatment for a clear condition.

 - NYU Neurology - Dr. Soujel Najjar and Kimberly Menzer – NYU Neurology- New York, New York, USA
 - Criminal Fraud and Negligence →
 - Extensive blood test reports are falsified in the hospital setting
 - 2014 After June – Dr. Valentine Riteri
 - 2 appointments with NYC Psych Doctor where no medications are prescribed and isn't a treating physician
- 16. 2015 December to February 2016

- Dr. Vladan Milosavljevic - New England Neurological Associates – Lawrence, Massachusetts
 - Criminal Fraud and Negligence →
 - Fraudilates EEGs EMGs and Blood Tests
 - Dr. Maosong Qi
 - Possible Fraud
 - Possible fraud in blood tests
- 17. 2016 to 2019
 - Insurance Restriction
 - Using Insurance to limit affordability of medications for progressive neurodegenerative condition.
- 18. 2016 March 27th
 - Under Dr. Yotin - Bangkok Hospital, Bangkok, Thailand -
 - Criminal Fraud →
 - Though Dr. Yotin is a treating physician the Lumbar Puncture results are falsified in the hospital.
- 19. 2016 March 20th and 21st
 - EEG in Bangkok Hospital - First Day of Recording
 - Under Dr. Yotin - Bangkok Hospital, Bangkok, Thailand
 - Criminal Fraud – Falsified medical report that ignored medical data when the patient (me) has clear gross evidence of seizures during the EEG.
- 20. 2016 April 21st
 - Bangkok Hospital Epilepsy, Bangkok, Thailand
 - Possible Criminal Fraud →
 - Hospital Epilepsy clinic most likely falsified the EEG report.
- 21. July 25th 2016
 - Dr. Jacob Sloan, Beth Israel Hospital, Boston, Massachusetts
 - Negligence →
 - 2016 Asking For Help in a Serious Condition- Dr. Sloan Denies Treatment or Diagnostics in Beth Israel Hospital
- 22. 2016 July 7th
 - Dr. Robert Fox, Cleveland Clinic, Cleveland, Ohio
 - Negligence →
 - Denies Treatment or Diagnostics in Cleveland, Ohio
- 23. 2017 January 10th
 - Riga 1st Hospital Radiology – Riga Latvia
 - Criminal Fraud that shows all other MRIs are also Criminal Fraud →
 - MRI is Falsified with a high resolution video to show how it was falsified and how falsifications in radiology are perpetuated
- 24. 2017 April 7th and 2017 May 12th
 - Dr. Paul Raffer – Sharp Hospital, San Diego, California

- Criminal Negligence →
 - Dr. Raffer denies medical treatment for MS in Sharp San Diego

 - Emergency Department – Sharp Hospital – San Diego, California, USA
 - Negligence →
 - The ER department ignores clear optic neuropathy due to MS

 - Emergency Department - University of California San Diego (UCSD) Hospital – San Diego, California, USA
 - Criminal Negligence →
 - ER denies treatment with a clear presentation and MRIs in a severe medical state warranting that I get the IV medications abroad immediately thereafter (in Mexico City, Mexico).
- 27. 2017 August 25th (Imagen Radiological), August 9th and 24th (Nucleo Radiologico Avanzado)
 - Imagen Radiological Integral and Nucleo Radiologico Avanzado – Tijuana, Mexico
 - Criminal Fraud →
 - Imagen Radiological Integral - Radiology falsifies MRI Report- Gross features of MS in the MRI so makes the report impossible
- 28. 2017 September 9th
 - Dr. Miguel Balanzario - Hospital Angeles Acoxpa, Mexico City, Mexico
 - Criminal Fraud →
 - Hospital falsifies the Lumbar Puncture (LP) test
- 29. 2017 September 25th onward till September 17th 2018
 - CI3M Radiology Clinic – Mexico City, Mexico
 - Criminal Fraud →
 - Multiple instances of fraud in radiology reports that are a direct contrast to the progression of the clinical syndrome and course of medications.
- 30. 2018 March 13th,
 - Dr. Daniela Bermphol- Charity Hospital Berlin and Labor Berlin, Berlin, Germany
 - Criminal Fraud →
 - The doctor and the hospital falsify the results of a LP test that is immediately proven to be falsified since several ERs occur during the same period requiring ER and outpatient treatment
- 31. March 11th and March 16th to 17th, 2018
 - Dr. Pia Schumacher, Dr. Benjamin Hotter, and Dr. Kaspar Streitberger, Charity Hospital Berlin (Virchow and Mitte), Berlin, Germany
 - Criminal Negligence →
 - Dr. Pia Schumacher and the other doctors deny medical treatment in a emergency setting for gross lesions and spinal atrophy clear in the MRIs

32. 2018 April 10th
 - Dr. Patima Orrawanhanonthai - Bangkok Hospital, Bangkok, Thailand
 - Criminal Fraud →
 - Lumbar puncture tests results are falsified
33. 2018 June 14th
 - Dr. Justin Dominick -Sharp Hospital San Diego, California
 - Criminal Negligence →
 - Lies about all the MRI data to further the medical negligence with a clear gross presentation of MS
34. 2018 July 16th
 - Dr. Jonathan Carter - Mayo Clinic – Phoenix, Arizona
 - Criminal Negligence →
 - Dr. Jonathan Carter and Kate Grimsrud (Mayo Clinic Arizona) lie about MRIs and denies medical treatment.

 - Criminal Negligence →
 - Dr. Williams denies treatment for MS with clear gross features of MS.

 - Criminal Negligence →
 - Dr. Philip Kinkle tries to lie about the quality of optic neuropathy in his report and denies medical treatment
37. 2018 October 23rd
 - Dr. Luis Enrique Amaya Sanchez - Hospital Angeles Pedregal, Mexico City, Mexico
 - Criminal Fraud →
 - The hospital falsifies the LP Test results though the doctor is a treating physician
38. 2018 November 8th
 - Dr. Elizabeth Soto Cabrera – Hospital Angeles Tijuana, Mexico
 - Criminal Fraud →
 - SEP test is falsified with clearly erased values (amplitudes) and inappropriate interpretations
39. 2019 January 21st
 - Dr. A. S. Arora – Apollo Hospital, New Delhi, India
 - Criminal Fraud →
 - Falsified Radiology Report and to an impossible extent, makes it clear that there is an intent to falsify medical data.

 - Dr. S. Catania - The National Hospital for Neurology and Neurosurgery
 - London, UK

- Fraud →
 - Falsifying SEP (sensory evoked potential) tests in a medical setting with the intent of hiding the disease pathology around the neurodegenerative condition, multiple sclerosis.

 - The National Hospital for Neurology and Neurosurgery
 - London, UK
 - Support of fraud and medical falsification →
 - After Dr. Anand Trip made false statements with respect to MRI series that show gross features of Multiple Sclerosis in his office appointment he tries to support Dr. S. Catania in a falsified diagnostic test.
