Hello Stephanie,

Dr. Trip's recent malice was already informed to the Healthcare Ombudsman and the GMC (General Medical Counsel).

It would be wise to review this case because whether its reviewed now or not it will come back to the police due to the circumstance of immigration and asylum.

This case is tied to the home office in an asylum case for immigration.

The doctors would eventually have to be forced to give medication through law enforcement since the basis of asylum is medical professionals trying to physically/intellectually disfigure a patient through medical negligence (withholding medications to intentionally physically harm the patient), which is what the medical professional predictably did in this setting with clear evidence.

The medical diagnosis of MS isn't debated with long term MS spanning over a decade with medical diagnostics to substantiate but the attempts to limit help and ignoring medical diagnostics in clear situations of medical need is apparent.

The case is unavoidable due to immigration because of this reason:

1. Since Dr. Trip and Dr. Catania knowingly falsified medical data with the explicit knowledge that I am in asylum in the UK and then proceeded to assault me with clear evidence it constitutes a "foul" in immigration law, which is illegal (replicating the harm of the country escaping from). Since the basis of asylum is an easy to demonstrate situation of medical professionals trying to physically/intellectually disfigure a patient through medical negligence and malice in medical settings Dr. Trip is simply an extension in supporting criminal fraud and criminal negligence in a foreign nation.
2. Whether directly through police or through immigration, the situation is the same. A criminal case against Dr. Trip for trying to harm a patient to uphold clinical fraud in his medical setting. Expect through immigration he would be tied to a much larger criminal case with an overabundant amount of evidence to substantiate.
3. In trying to support the clinical fraud of other criminals (in what is a felony crime) in foreign nations to physical harm Dr. Trip and Dr. Catania become accomplice to felony, which is clear and easy to demonstrate in this case in this country and the next.
4. It would be wiser for Dr. Trip to simply admit to the entire clinical fraud and malice because of the consequence in this case of the entire criminal case.
5. I will still need the medical help in future ED (Emergency room) settings and outpatient doctor settings to try and stabilize the condition so if Dr. Trip tries to limit help in those situations he would only get more reports of assault filed against him and that would have to be reviewed by immigration again and police again. It's unavoidable.

So this case is unavoidable.

The background of how this case is related to a larger criminal case and asylum/immigration proceedings is attached. It's an explicit and easy to demonstrate case and Dr. Trip's recent behaviour makes it even more explicit. This is simply a listing, the overall case is very clear and explicit.
