Hello Ms. Levene,

You reviewed my case before in early January 2020 but was not sure you could take the case. Since then my case with the clinicians has evolved in a new direction that would indicate criminal intent on the part of the physicians (with evidence of criminal intent). We ended our last communication with the demonstration that the clinicians falsified some data sets to uphold clinical fraud in other settings.

But the situation the clinicians has evolved in recent instants (April 2020) of assault in a ER (Emergency Room/Department) settings, where the patient (me) is in a severe medical state (which I recorded, hemiplegia due to a Multiple Sclerosis relapse) and the clinicians in ER did two things 1) withheld medication in a severe clinical state while citing the false statement of the initial clinician in question and 2) falsified the clinical reports in ER with clear evidence of clinical fraud.

I reported these events to the police (which they mentioned as a form of assault). So now it would be a combination of clinic fraud and negligence in emergency situations with the intent to cause.

So, if you are willing to look at the evolved situation I could send you the recent data to see if you would be willing to take the case. The case is clearly and completely explained. With all records and negation of the records included to show what the intent of the clinicians are.

Hello Claire,

I received the responses to the UCLH complaint yesterday and they still appear to be unwavering with respect to something that's clearly abnormal in the data.

I attached the UCLH response (UCLH Complaints Department Response-Narendra Jana.pdf), the SEP and VEP graph data (which shows clear clinical aberrations not acknowledged by UCLH), the EEG report and the EEG follow-up appointment summary. I attached the EEG report because I believe the EEG report fails to mention some clinical features in the EEG recording (the EEG needs to be analyzed again).

The UCLH complaint response isn't hard to negate, I attached a statement by statement negation of the response (Statement by Statement Negation of UCLH Complaint Response-Narendra Jana.pdf). My case against UCLH isn't hard to demonstrate.

I included the entire complaint to UCLH and the attachments.

The complaint hasn't been responded to yet.

Since then I did obtain the full graphs from the test and an EEG recording done on the same day (both would be useful for a medical expert). The only record not obtained from UCLH is the video for the EEG, which they stated was erased due to disk space use. (which I could send)

I also did my personal research done from medical text books in the medical library (its very easy to demonstrate the false statements in the report). It would make a medical experts job easier.

The original email to UCLH complaints is given below:

"Hello UCLH Complaints Department,

I stopped by complaints department yesterday and spoke with Ms. Angel Bellot (the head of the complaints department) to file a complaint. She stated send an email here and she should be able to pick it up.

I attached the documents for the complaint:

"Explanations for the UCLH Complaints Department-Narendra Jana.pdf" explains the entire scenario.

"Dr. Anand Trips Summary Before Diagnostics - Narendra Jana.pdf" and "VEP and SEP Report - Narendra Jana.pdf" are the original medical documents.

I stated in the first PDF that the concession should be "that in situations like this to start acknowledging that the test is mis-typified and rectify it while explaining why it was mis-typified."
