Primary Care Physician - Dr. Gary Trey:

Dr. Gary Trey is the primary care physician at that moment in time (main physician, GP) when gross medical negligence is taking place. He does understand the nature of the condition and the neurological underpinnings of the condition. He prescribes a anti-inflammatory medication (para-aminosalicylic acid) by my request. Its not the treatment that's effective or typical of my condition (plasmapheresis and dialysis would be required given the extent of the metal toxicity) in addition to blood and cerebrospinal fluid tests for toxicology, and brain and spine MRIs for neurology.

As a medical doctor he is required to write appointment by appointment notes to track the progress of the patient.

Dr. Gary Trey's office doesn't materialize any medical notes and there are no medical records of him being a primary care physician in the hospital, I believe in order to avoid involvement in the case that took place in the other Harvard Group Hospitals (Mass General and Beth Israel). There is an audio included titled "Dr. Gary Trey is Evasive about Records" in the USB that clarifies this (2-Videos and Images of Crimes Being Committed to Cause Harm > Evasiveness to Avoid Case > Dr. Gary Trey Being Evasive About Medical Records).

Though his personal notes and prescriptions are missing the other doctors who forwarded notes to Dr. Tray, typically write CC: to Gary Trey. Not all but many of the records from other doctors are missing.
