The state of Massachusetts is the cause of the medical neglect and fraud since 2008 and sever medical mistreatment started in in 2008, December:

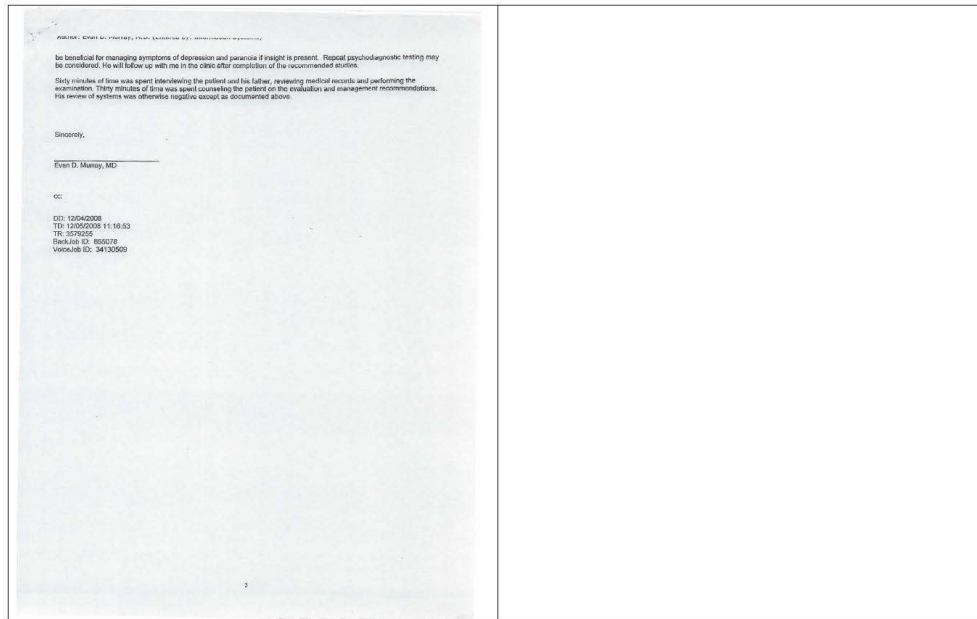
Dr. Evan Murray is the start of the medical neglect in Neurology:

I should start by giving an idea of my general history and the primary suspects in those who started the malice.

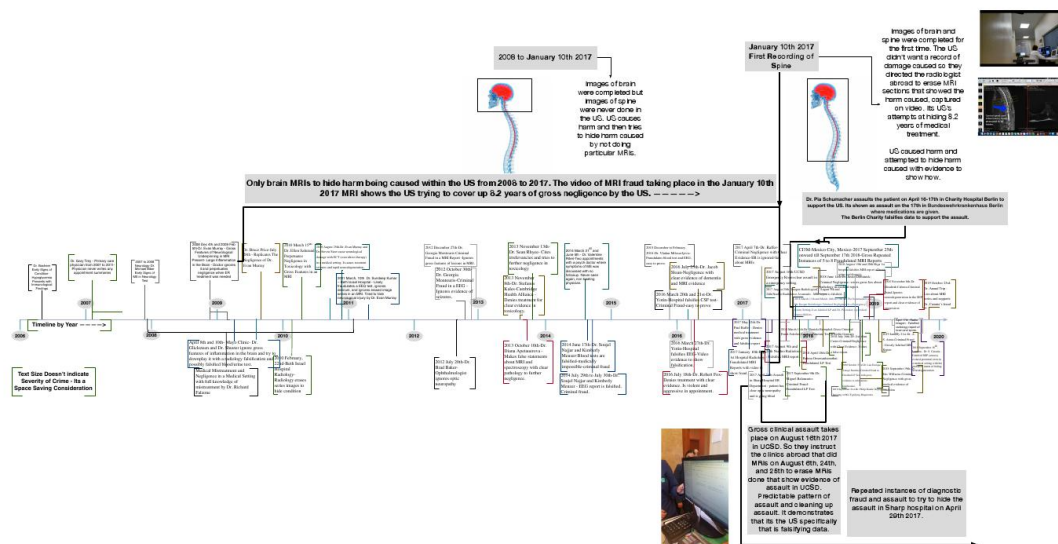

Why did adamant medical fraud take place in specific time periods in foreign nations as directed by the US?



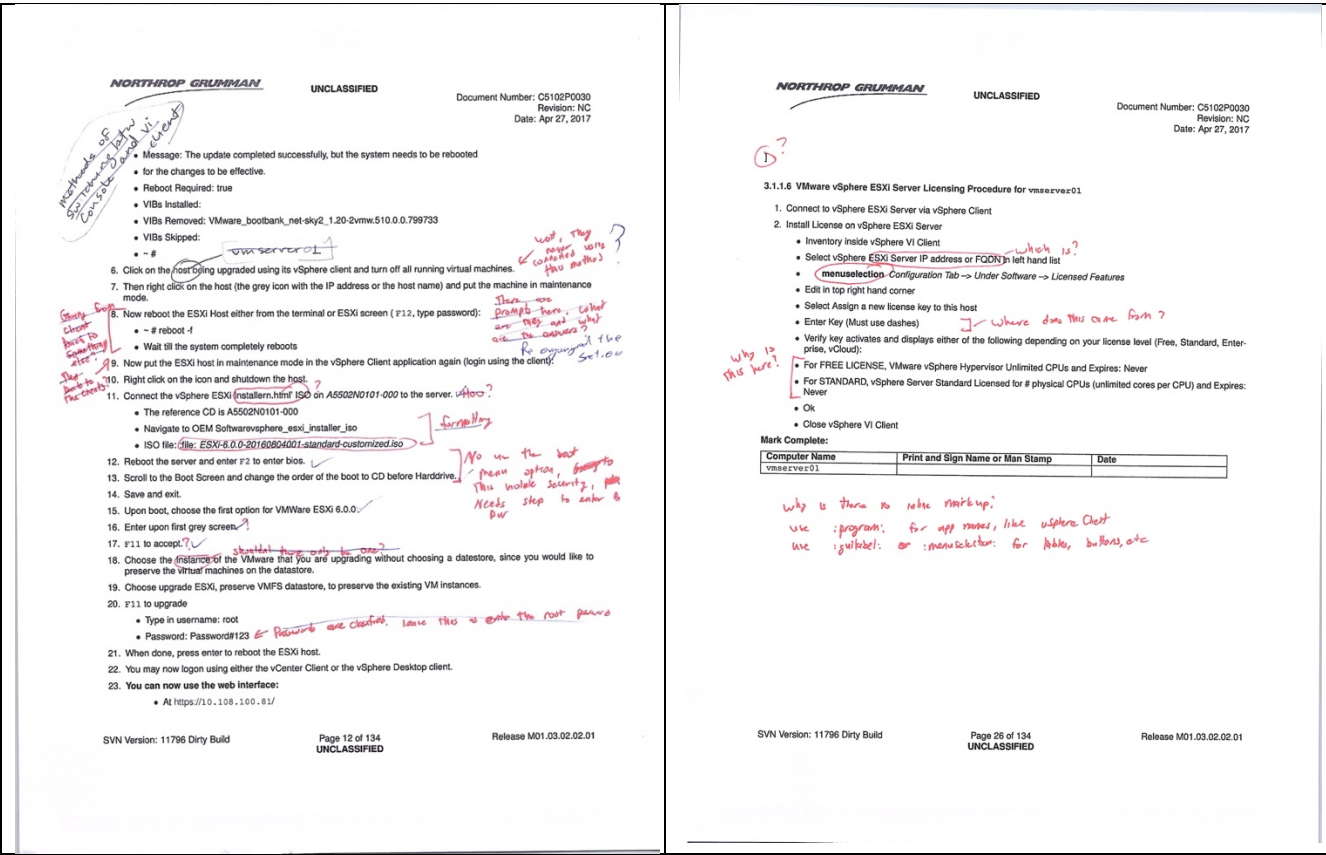
Because it shows with easy evidence that the US grossly medically mistreated the patient in a large time span from December 2008 to January 2017.
