**Reasons for refugee and no other basis for immigration (how it fits the criteria of refugee):**

The historical definition of refugee is: Race, religion, nationality, political opinion or membership in a particular social group. One is "medicine is bad for you and will make things worse". If you don't have the natural ability to be strong then you cant adhere to medicine to make you healthy. Medicine is easy in the US but they lack basic understanding of biology or medicine wy its important. They

cant read basic medical inserts or guidelines and have troubles following along with science and biology.

I responded:

“I didn’t sign up for this, I can understand basics in biology and medicine”, we grew up with it in high school as part of our curriculum; we need medicine and there is never any social cause or bias in medicine. To them medicine is a social cause. =

I’m being persecuted by the uneducated and uneducable about biology but they are often in positions of power. Arnab is the definition of uneducated and uneducable, the other politicians are also definitions of it, a total lack of basic understanding that causes disproportional harm by disability of a group of venerable people (which they know but still won’t/do not have the capability to educate themselves).

**Their persecution of me now is their long term not wanting to get caught, so they resort to character mis portrayal or cheaper and cheaper harm. Physical harm (more recently physical assaults) and then trying to murder me (a few murder attempts).**

More recently they have been trying to assault me in medical settings for me simply being right in a clear way. They misinform and mislead other countries either bullying those of sane intellectual quality (often they bully doctors that know far better) by pushing for a social cause vs. simply biological. And their social cause is also falsified. Some doctors in foreign nations are readily willing to give the treatments and they have extensive experience of 25 to 40 years of doctorhood and they are being bullied by non medical political persons in the US.

So my reason is
