In University my study abroad programs were more obvious in how they physically separated me by separating me from females. My apartment was separated from females in the program. No contact exchange between me and the female participants of the program was forced by the US; preventing relationships. This was in Madrid, Spain. Not exchanging contact information to prevent communication was a way of avoiding communication then. The students would literally be forced to avoid me after our school work by the US.

In my second study abroad program in Leeds, England I was physically isolated from those in my age group and females in general. The program had the same format of not exchanging contact information with people of the opposite sex and those my own age. The dorms were decrepit as well relative to the cost expenditure of the program; which indicated some sort of invectiveness in physical isolation.

US responded "we made it too "obvious"" in separating woman and possible friends from me and then places devoid of females/people for 8 years. And in my study abroad programs the females are restricted to interact with me after introduction. The woman and people my age

liked me but I hung out with them but I wasn't allowed to go to their places of living even thought they had a desire for me to be there. I was US restricted to go there.

They couldnt cover it up in their imagination as well, it became a crime against psychology when they tried to cover it up.
