

Tokyo, Japan Clinical and Physical Assault.

The idea of medical mistreatment to that extent has never happened in the US. And that is why they are so aggressive to hide it. They hide it to cause social disfigurement for perpetual persecution. If a person is physically or intellectually disabled there would be perpetual persecution.

Social isolation by the US to the point of virginity at age 39 is a **human rights violation (these are UN human right violations)** by the US. This goal by the US ties closely into the goal of physical disfigurement by medical neglect that the US has perpetuated for 15 years. Virginity at age 39 isn't by my choice it's by physical separation of me from the opposite sex by US force; US militarized force. I am a heterosexual male.

The same physical separation also applies to friends in general and has existed since age 17 (before I had reached puberty), I am physically separated from them. All social isolation is physical social separation by the US. They use medical neglect to physically deform people (me) to make me less socially or physically appealing to limit opposite sex relationships. **The reasoning by the US is that the less people I know the more harm they can perpetuate or the more persecution they can extend and avoid other people knowing.**

So it can't be a medical pass, it would by definition have to be a full refugee to physically protect me in medical settings so that doctors have a legal repercussion if they deny medical help in emergency or any setting. It could be as far as physical guards to protect me from certain situations. Because of assault.

The US also has another predictable behavior, as a cover to extensive medical neglect US cites psychiatry when in example, I have gross optic neuropathy and clear multiple sclerosis in ER and medical emergency settings. They tried three times recently and all three doctors agreed that I have a gross presentation of multiple sclerosis that has to be treated in a neuro clinic. But yet the US restricts it to something that they can hide and get away with.

There are repeated human rights violations. They get angry and frustrated. I'm US force militarized to no physical or psychological human contact. I make friends and those friends are force restricted from me so I don't make it to their personal spaces and they don't make it to my personal spaces. They use informatics to do this.
