Summation

The object of the US military/US government led physical harm/brain damage and physical extreme pain torture is physical disfigurement, or physical immobility for the sake of creating a reason for discrimination and persecution. Its to create a physically disfigured or intellectually inept person to limit livelihood and social perseverance. Its to create a difficult to deal with or physically undesirable person through neurological damage. If the US caused enough neurological damage they could use the damage caused as a reason to limit social interaction, limit basic livelihood, or create a sentiment of "odd" or "unintelligent person". They are trying to change an atheist to a religious person by causing a dementia (people with dementias suffer from hyper religiosity; its a neurological effect). They are trying to create a social group of "medically disabled" by perpetuating intentional physical harm. US force isolated me from all adult females and all interpersonal relationships for 2 decades. I am heterosexual but the US aggressively forced virginity in the US and abroad to age 38 by aggressive social isolation.

Highlighted Points

1. Introduction to the asylum interview
 - a. The US intentionally kept me sick to disable me for about 15 years. US intentionally keeping me sick includes physical torture by physical pain to the same effect as leaving a person's head and arms over a burning stove for 15 years. Its directed by the US military and US government in effecting a civilian, me.
 1. Its medical "bio terrorism", a different way of harming a person but still to extreme physical pain and physical torture by intentional medical harm.
2.
 - i. They tried to hide the condition but that doesn't mean that the physical pain goes away; it's a continuous medical condition where the physical pain never remits unless they give hospital help. They restricted all hospital help in the US for 15 years.
 - ii. They tried falsifying data to hide, but it doesn't mean that the physical pain goes way, its simply means that they tried to hide it while leaving me in gross physical pain.
- b. Important examples of their harm:
Theft to steal medications in foreign nations as directed by the US to keep me sick.
 1. They steal medications to keep me sick.
 2. I bought \$2500 of medications for my condition and they stole it in Brazil to keep me sick. They stole it immediately after I bought my medications.
 - a. The theft is captured on video (security camera).

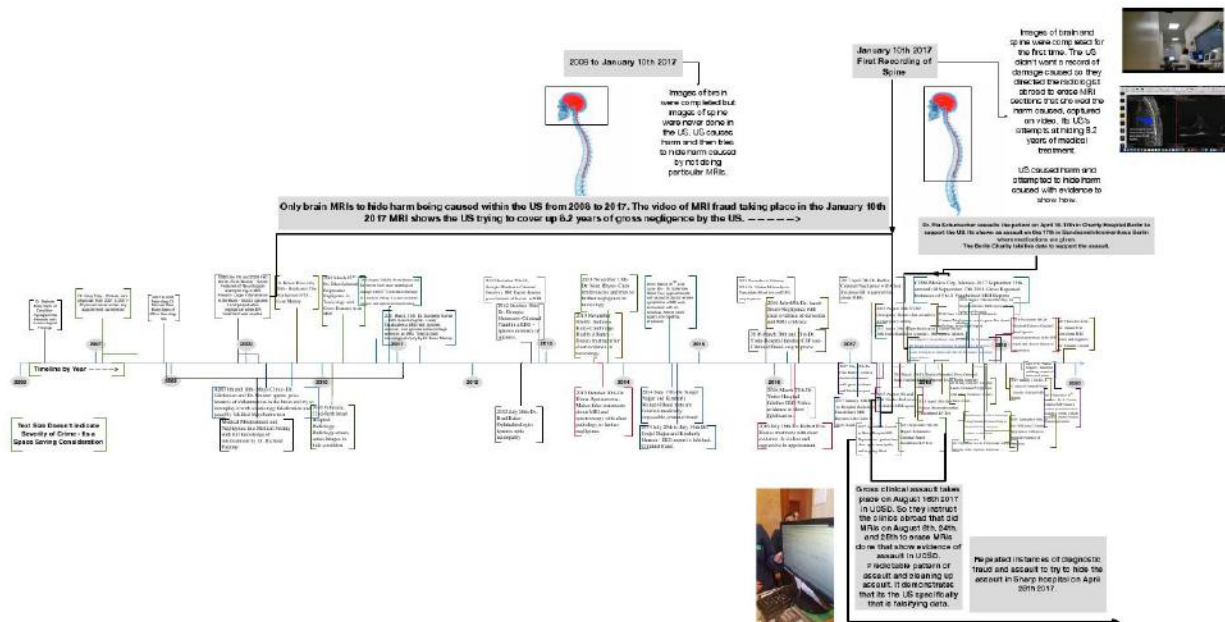

3. If it wasn't by stealing medications they limit MRI diagnostic data that shows the medical condition to limit medical treatment.
 - a. They often falsify blood tests to keep me sick. From 2008 December to 2017, they wouldn't do specific diagnostics (MRIs) of the spine knowing what my condition is. They played with the MRI recordings to try and hide the pathology.
 - b. In future instances they hide assault by medical doctors by erasing diagnostic data.

This graph clarifies it:

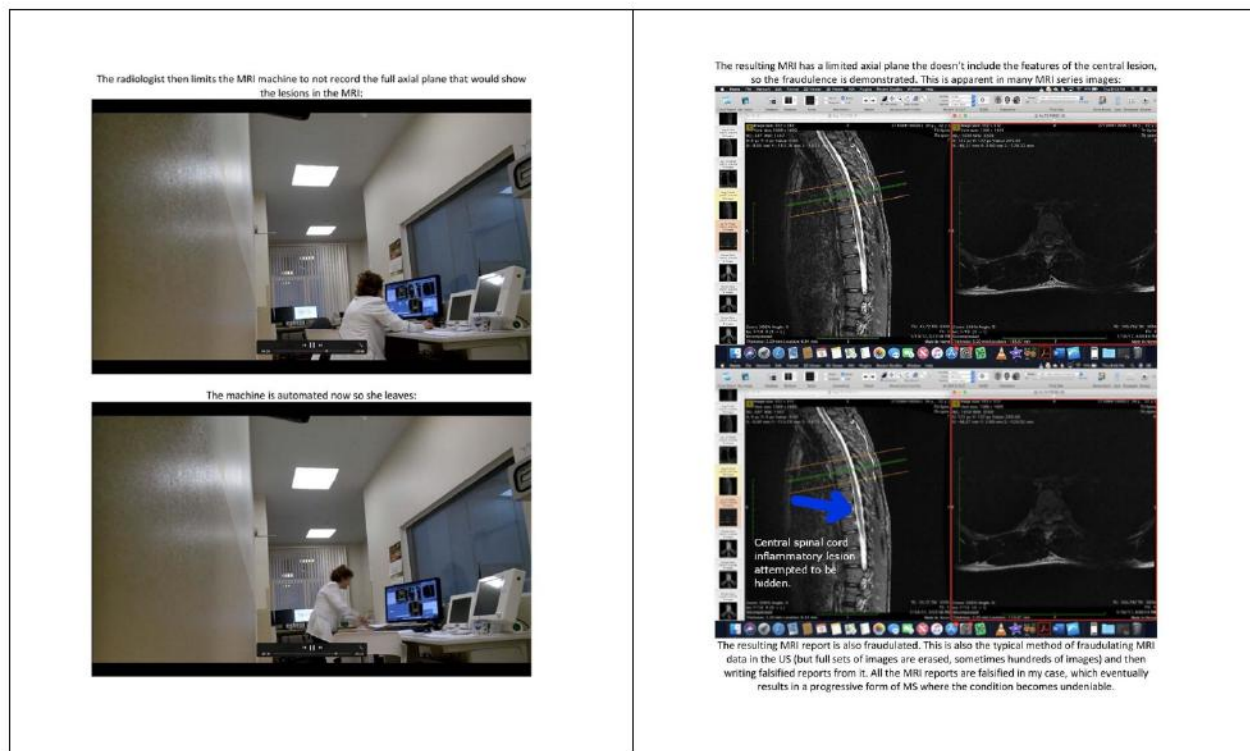
Why did adamant medical fraud take place in specific time periods in foreign nations as directed by the US?



Because it shows with easy evidence that the US grossly medically mistreated the patient in a large time span from December 2008 to January 2017.

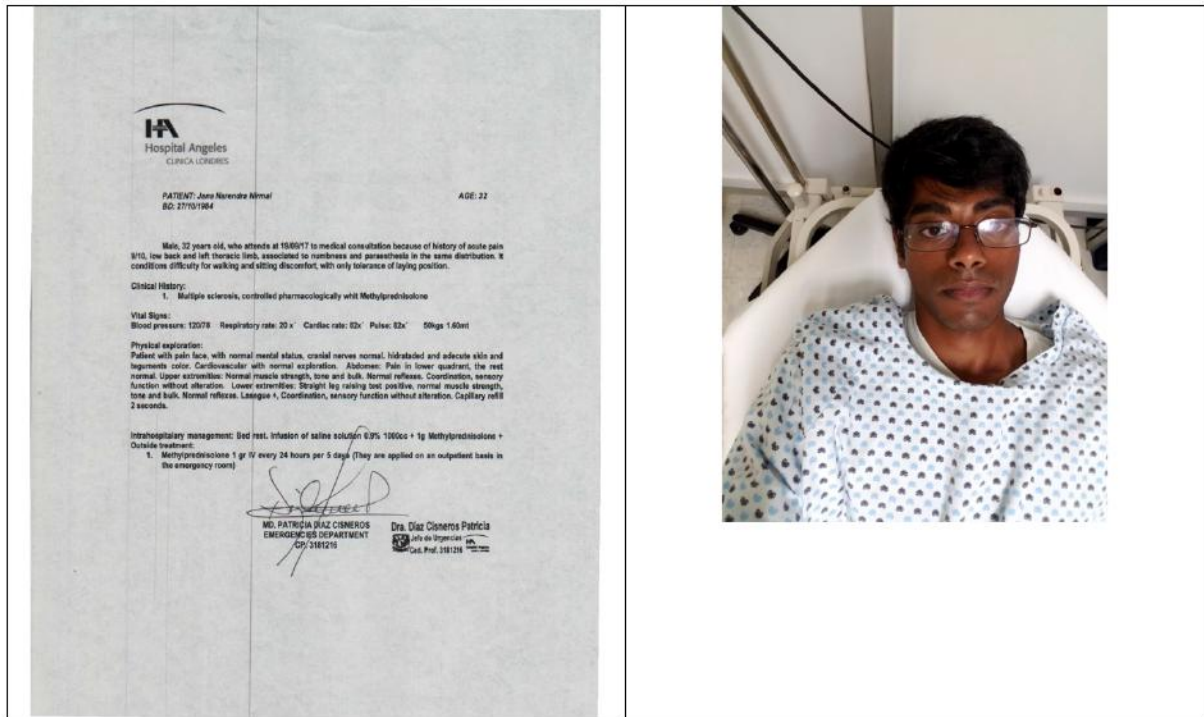
Its to not admit to past instances of clinical harm in medical settings between 2008 and 2017 which was criminal in the US.

1. Radiological fraud in foreign nation (Riga, Latvia) after almost a decade of negligence in the US shows that the US tried to erase sections of a MRI image to hide the harm they caused. This video of the radiologist erasing the data/modifying the recorded image is shown below:



She erased 80 percent of the MRI image show in the video to try and hide the disease.

- i. It was led by the US in what they did to cover up the medical harm they caused. They falsified the diagnostic the moment I left the US in the very first MRI of the spine. That was the first MRI of spine done and the first time outside the US.
 4. In the following example they erased MRI data (diagnostic data) that shows the doctor assaulting me in the US hospital (hiding data that shows assault)
 - a. Assault is in a emergency room setting in the San Diego, Sharp Hospital ER and UCSD ER with evidence to show the assault and their intent in assault.
 - i. The doctor in UCSD hospital sees the neurological condition worsening, states its clear multiple sclerosis and then states she simply would not give the treatment in a severe clinical state. Denial of treatment is a hospital assault to cause harm in that instant.
3. After this assault I went abroad to get emergency medical treatment to stabilize the condition.

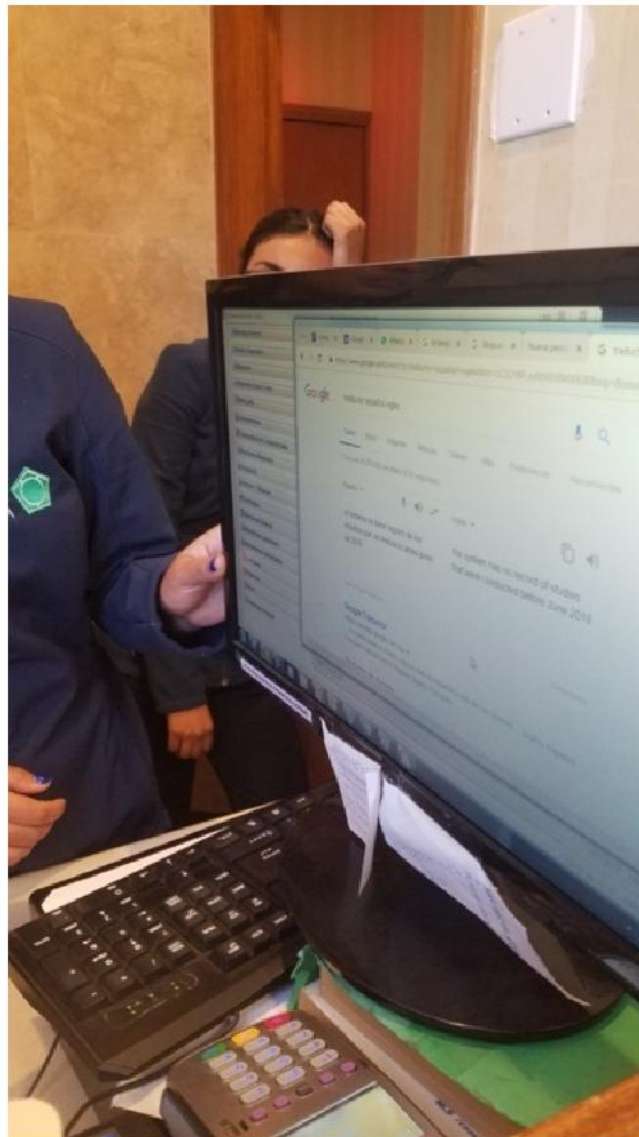


The foreign doctor had to help me after the United States caused harm to me, she didn't know it was the United States causing harm to me.

a.

- i. Hospital assaults are repeated in my case, repeated in Massachusetts and then New York, Florida, Ohio, California, and Arizona. Hospitals assault is medically harming a person in a hospital.
- b. In the image below US doctors erased the MRI images that they showed they assaulted me. They instructed the foreign MRI clinics to erase the MRI images to hide the pathology.

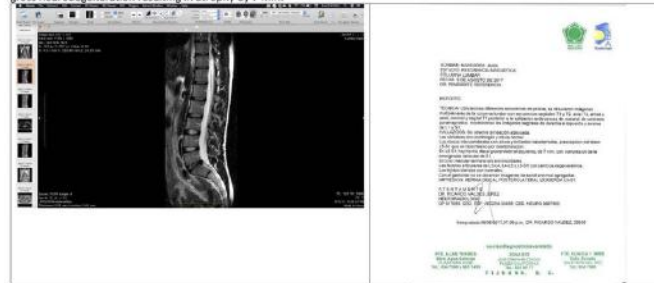
Two MRIs are done in Nucleo Radiológico Avanzado in August 2017.

First of the Lumbar in August 9th and the second of the Thoracic in August 24th.

The Lumbar MRI shows gross neurodegeneration.

By January 2010 it was already clear that the US was instructing foreign nations to falsify radiological reports of MRI data (with a video recording of the radiologist erasing the MRI data) or to erase MRI data that shows medical pathology.

The neurodegeneration is extensive from already long term MS, from lumbar column L3 to L5 down to sacral spine S1. S1 shows gross neurodegeneration resulting in atrophy by 7 mm.

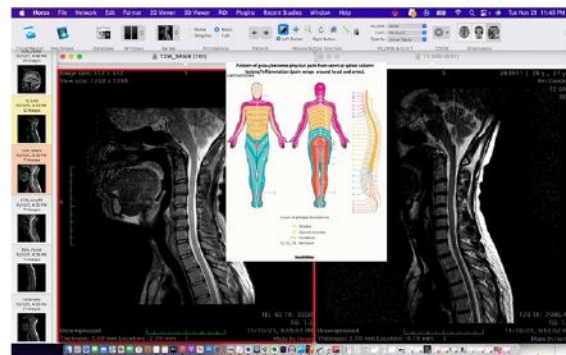


They hid the assault that took place in USCD and SHARP hospital San Diego.
 Show the video, the article, the situation in Mexico. The falsified diagnostic reports.

- c. They often hide the data that shows their crime. But I found the data that they hide and saved it. If they give only sections of MRI series to hide the condition, I find the full MRI series that shows the condition most times.
- d. So they falsify the MRI report to hide the condition when the diagnostics show a gross pathology as clear as a fractured wrist in a MRI. Something that anyone could figure out. Difference is mine is brain and spine, not skeletal.



The fracture (not mine) is obvious above.



My medical condition is obvious above. Clear.

5. US has a pattern of harm due to past harm, inability to come to terms with their harm so they cause more harm.
6. They make up excuses to cause harm and cite non existent US doctors to try and validate their mistreatment. They cite non treating doctors to mistreat me.

7. Their entire case is making up excuses to cause senseless harm.
8. They restrict basic tests to perpetuate the condition or erase diagnostic data that shows it.

Situation in the US


The overall situation in the US and historical events that resulted in asylum in a foreign nation. First United Kingdom asylum foul (where the United Kingdom replicates the crime of the original country of refugee from) and then Japan for asylum.

- i. They committed 47 fully recorded instances of fraud, negligence, assault, and clinical malice that caused repeated trips abroad from the US in order to try and find treatment for the clinical condition.
- ii. Its believed to be a Arnab Raychaudhury (someone I knew when I was younger), who led the government driven malice in the US when he worked in the Barack Obama administration in 2012. Its believed that Arnab works in the US army.

The US medical assault is daily for 15 years (they keep me sick everyday in gross physical pain):

The overall effect is that it caused progressive neurological damage to the optic nerves, brain, and spinal column (which is easy to demonstrate in MRIs).</p> <p>Each instance of criminal fraud is an added instance of aiding and abetting a criminal to further negligence.</p> <p>Their mindset is similar to common criminals, an attempt at avoidance of the illegality of criminal fraud by further perpetuating criminal fraud in another setting. They believe it's a convincing crime when its easy to show otherwise.</p> <p>Each instance of fraud, malice and negligence is typified in this list as what could only be described as unrealistic and easy to prove instances in malice attempts in medical settings.</p>

1. They repeated medical harm from 2008 December.
2. US military started harming me with Dr. Evan Murray who is a US military/US army doctor. The US military then repeated the same harm in all subsequent doctors.

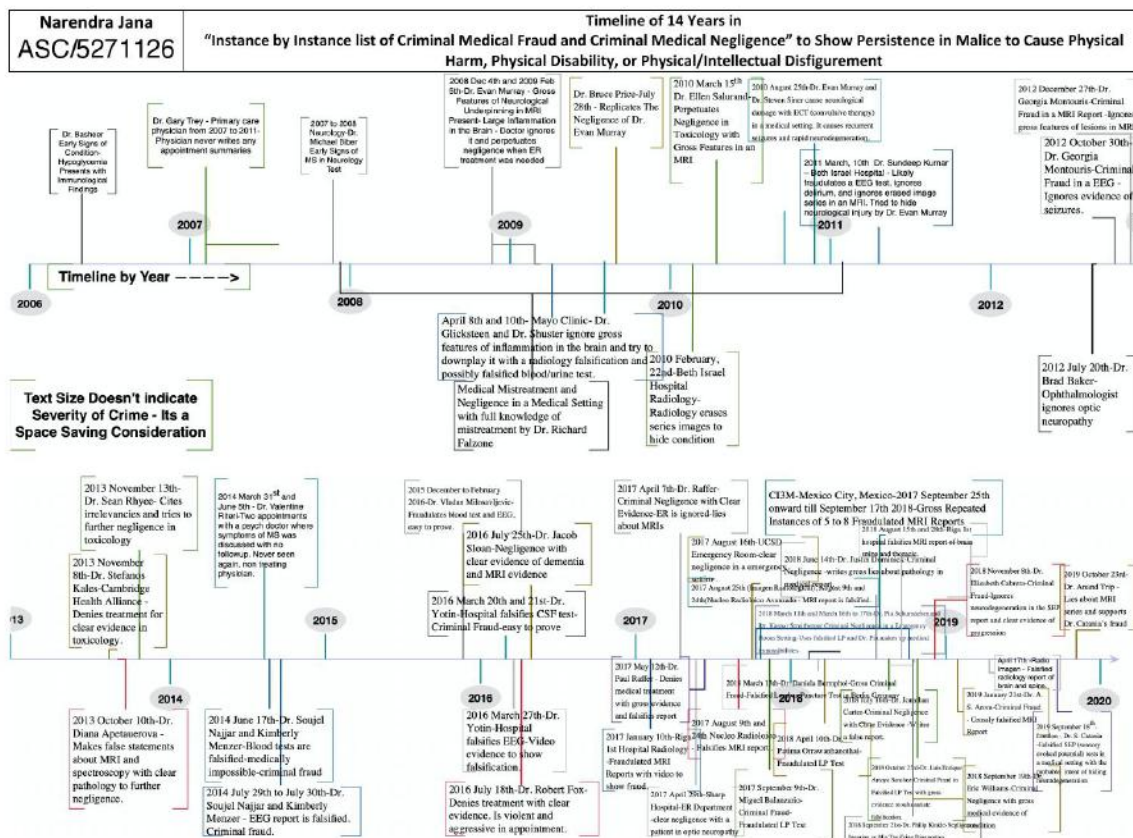
<p>Late 2008 and Early 2009 2008 December 18th • Dr. Evan Murray - Belmont, Massachusetts, USA • Criminal Negligence →</p> <p>Gross features of multiple sclerosis (neuroinflammation) present by December of 2008 and the medical images from the medical tests are ignored: The neuroinflammation is due to medical toxicology, namely a manganese metal toxicity. Under toxicology it's a gross finding.</p> <p>The first MRI was taken in December, 18th, 2008: There is a very large intensity in the basal part of the brain. People with these features in a MRI are required to have intensive diagnostics (lumbar punctures and blood tests) along with intensive care for the underlying clinical condition (neurotoxicology that results in multiple sclerosis) in a hospital setting. Its like finding a large brain tumor in a patient and not acknowledging it and refusing to treat it. Nothing is done then, leaving the patient (me) in excruciating physical pain with no medical treatment for a decade with repeated attempts at asking for medical help (a time line of events is given), there were three different toxicologists in three hospitals (UMass Memorial, Mass General, and Beth Israel in Massachusetts) that were consulted and all refused to give the required detoxification treatment (IV medications with dialysis and plasmapheresis). It was later determined that the medical negligence was intentional with intent to cause harm (thus causing a need for asylum). Meaning it was negligence with the intent for causing physical disfigurement or physical disability (immobility).</p> <p>In the MRI below, the white intensity means a large part of the brain is inflamed. The neurologist is required to give a specific selection of medications to reduce neuroinflammation along with dialysis or plasmapheresis to prevent neurological damage. It could be likened to a brain tumor that is ignored and its atypical to see these features in an MRI series.</p>	 <p>Technical T2-weighted images were obtained in axial, sagittal, T1, T2, FLAIR, T2* sequences and proton density images. Coronal T2 and T2* images were obtained.</p> <p>Findings The brain shows a large, well-defined, hyperintense lesion in the basal part of the brain, consistent with a large brain tumor or a large area of neuroinflammation. The lesion is located in the basal part of the brain, near the base of the skull. The lesion is surrounded by a thin rim of hypointensity, suggesting a central necrotic or cystic component. The surrounding brain tissue shows normal signal intensity. The ventricles are compressed by the mass effect of the lesion. The cerebellum and brainstem are not well visualized due to the mass effect.</p> <p>Conclusion The findings are consistent with a large brain tumor or a large area of neuroinflammation. Further evaluation is recommended.</p> <p>Dr. Evan Murray is the clear etiology (origin) of criminal negligence and fraud supported by other doctors during that time period (Dr. Richard Falzone being the prime suspect).</p>

3. It became a repetition of the same crime where I am in gross physical pain due to multiple sclerosis caused by a manganese toxicity, but they simply wouldn't treat it repeatedly.
 - a. Its opportunistic harm by the US (they beat up the patient when they are down and in a state of gross suffering and try to hide it).
4. They then falsified diagnostics and repeated the falsifications to try and hide the condition while causing physical pain and torture with full knowledge.
 - a. Evan Murray is the underlying start cause of physical harm in the US along with the US army/military.
 - i. The physical harm is US military directed, the underlying cause is a US government person directing things in US military to cause harm to physically harm me.
5. The medical condition is similar to internal bleeding but the bleeding is along the spinal column, causing inflammation. The internal inflammation causes gross pain along the extremities of my body (around back of head and upper spinal column, then arms and legs). Its like continuous internal bleeding but its **more** than internal bleeding. Mine effects the spinal column directly effecting physical sensation in the entire body to gross pain. 24/7 extreme pain for decades if they don't give medical treatment. Its physical torture if they don't give pain medications.


- a. Its more than internal bleeding if the internal bleeding is along the spinal column, then its your entire body in gross extreme physical pain. Mine is spinal column.
6. They falsified brain seizure data (EEGs (electroencephalograms)) to hide seizures which is against the state law of Massachusetts. But they didn't want to prescribe anti-epileptics because they would have to acknowledge the condition. Not acknowledging the condition means they physically torture me leaving me in gross pain for decades.
 - a. Each doctor thereafter is instructed to falsify EEG data to hide seizures.



7. Since the US denied medical treatment from 2008 to 2017 in repeated instances of hospital assault and medical falsifications, the time line below shows the events from 2008 to 2017:



8. Then I went to 17 different countries seeking medical help.

I already knew that the medical data in the US was falsified to hide the condition so I flew to Tijuana Mexico to acquire the medications for MS. I consulted with a neurologist there and did an MRI but I also got a medication for MS, prednisolone. Prednisolone is the right medication but for those who have MS it must be given in IV at a high dose and not ingested (I later got the medication in IV).</p> <p>The result of not getting the medication in IV was this (severe skin rash and inflammation):</p>  <p>Dr. Williams - Criminal Negligence with gross criminal malice in the US.</p>

- a. The list shows how I sought help in foreign nations and how the US hindered medical treatment in foreign nations. Like the above example where they instructed foreign nations to erase diagnostic/MRI data after a US hospital assaults.
- 9. I left the US after 47 instances of medical harm in hospital settings in the US and abroad, with full evidence.
- 10. US intent is stated in hospital settings as to cause harm to me:
 - a. Dr. Robert Fox in Cleveland, Ohio stated that “whatever the clinical evidence you have we will simply ignore it” It’s a part of their psychology after 8 years of negligence that whatever data I present they will ignore the severity of my condition and mistreat it.
 - b. Dr. Fox’s statement is more aggressive. Its aggressive verbal abuse.
 - i. The neurologist claims that he cant read a MRI or a PET scan and whatever I present he will deny treatment.
- iii. After repeated harm by doctors, the doctors effectively stated we will mistreat you to death in US.

- 1. Fox’s audio transcript (audio recording available), the doctor is abusive on audio to hide the harm they are causing in the US on July 7th 2016:

Me: Its rare to have a [when younger at age 24] who has a sudden neurodegenerative symptom that never existed in 2006.

Doctor: Again, let me ask you what questions you have, You are actually telling me statements? Which is ok (stated in a condescending manner) but what questions do you have.

Doctor: Alright tell me what questions you have.

Me: Hmm, what, so you cant personally read the pet scan.

Doctor: Nooo (condescending manner), no I cant.

The doctor lied that he couldn’t read diagnostic data twice and stated that even if I had the diagnostics for MS that show I have MS (and coincidentally as in gross physical pain) then he still wouldn’t treat it.

- iv. Given the situation in the US there is a well founded fear for my life, I might be murdered if I am a US person (which they tried).

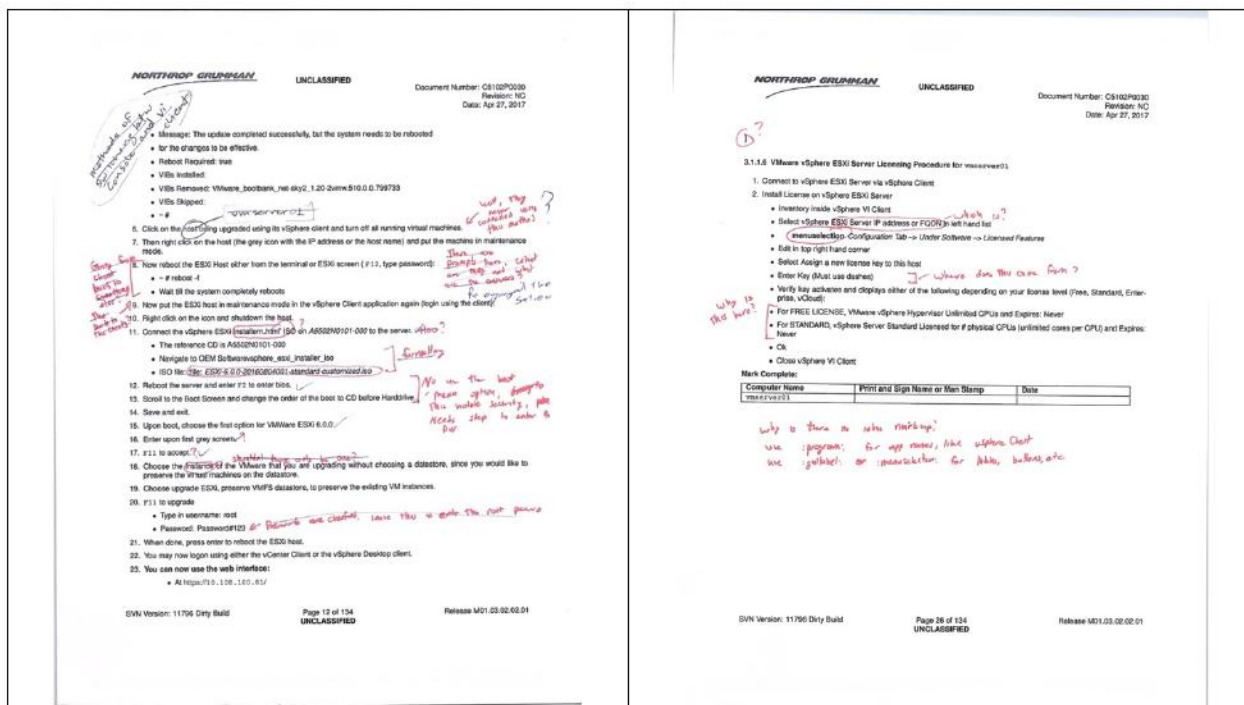
- 1. Their overall objective:

Repeated negligence/physical harm to cause a disability to create a social group of disability. Persecution of the created disabled social group by the US military. Persecution by intentionally created disability.

2. They are using the effects of MS to mistreat/persecute me, they created a social group of intentional disability by mistreatment to persecute.
 - a. Their intent is to cause brain damage to disability to limit job ability (ability to do your job). They limit perseverance in my case by causing brain damage. Those who are harming me are specifically afraid of high intellect, so they cause brain damage to limit job ability and career success.

Arnab Raychaudhury, the person in the Barack Obama administration (US government) and who stated that he is harming me, is specifically afraid of high intellect so he caused brain damage to limit my intellectual ability.

- i. Disability by brain damage to discriminate by reducing a person's intellect.
 - ii. They were trying to harm me to limit complex thinking, they are afraid of complex thinking.
 - b. US military caused neurological damage and then mis portrayed me in a work place as the direct involvement of the US military. We believe this is led by Arnab Raychaudhury.
9. The US military figured out that they couldn't mis portray me in a consumer company so they restricted employment to a US military contractor called Northrop Grumman (that's the only way they could mis portray me, if they fully controlled the employer). Most of it is directed by the US military as creating fake situations to create a admonishment of me for no reason.



i. They limited all other companies to employee me except US military controlled settings. I didn't know at that point.

2.

a. They make people less sexually appealing by intentionally causing a disability if they feel threatened. In my case their intent is to reduce sex appeal by causing a physical disfigurement by medical mistreatment.

i. They socially isolate me according to the idea that I would become physically disfigured if they perpetuate medical mistreatment.

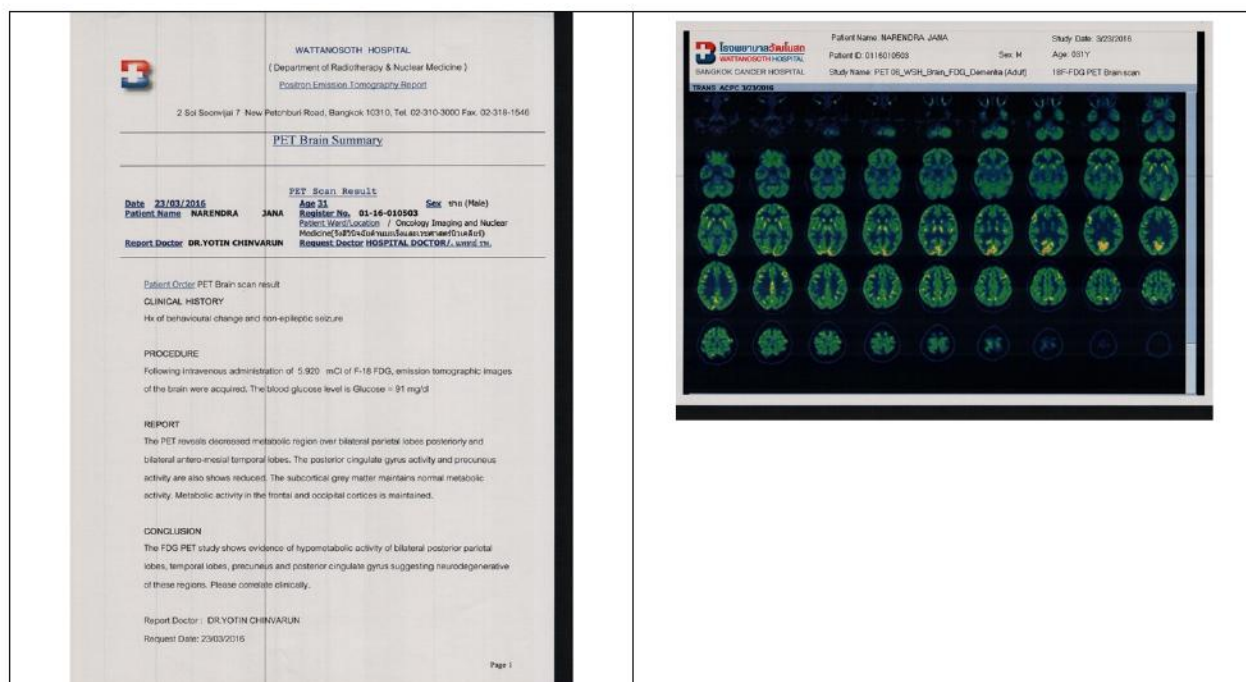

4. The effect of neurological harm is over recorded, every phase of the neurological harm by the US is recorded in detail. I cant stop the neurological harm by the US but I recorded it.



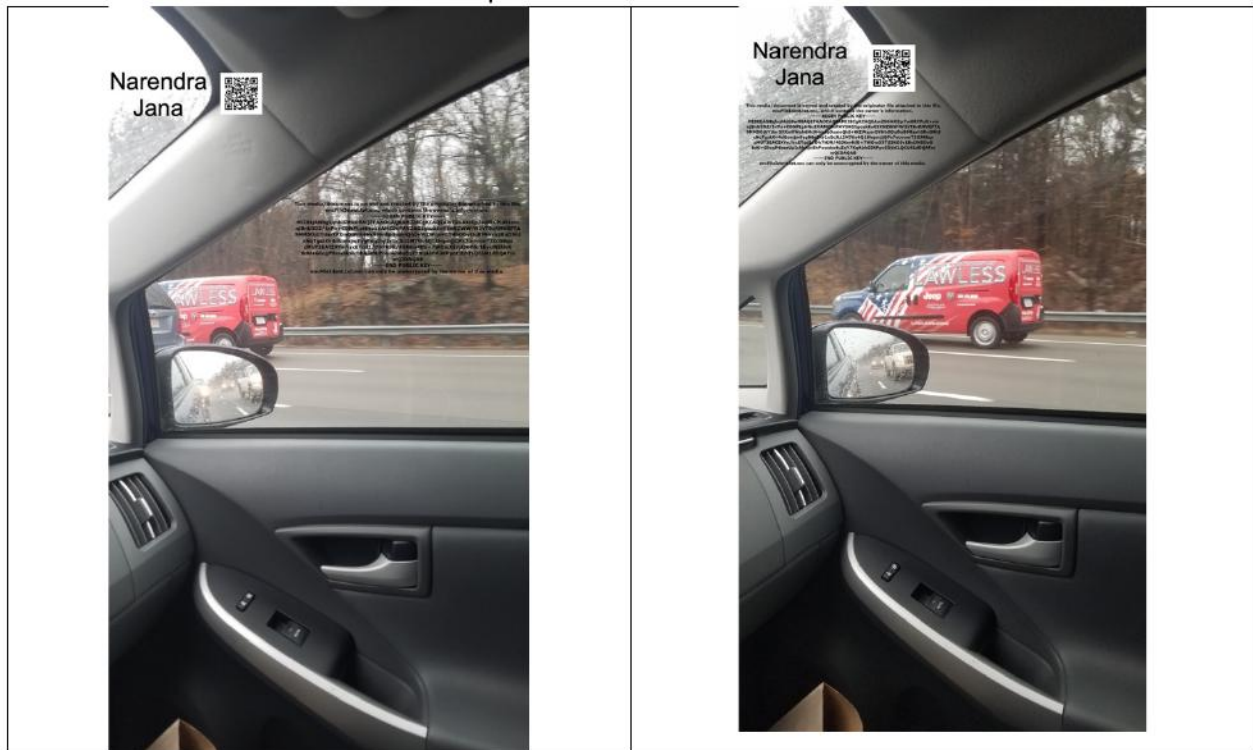
- a. I'm normal separate from the situation.
5. They have a intent to make me immobile to disabled by medical negligence.
6. They have an intent to make me blind, which they state often publicly, I have optic neuropathy and cortical blindness, but their intent is to cause total blindness.

The lack of legal representation in the US. There is no lawyer help to stop the harm to me in the United States. It's a crime that goes unchecked without any way of stopping it.

- a. If I inform the police of harm in medical settings they will state, you should speak with the medical board of the state or a lawyer. They the medical board denies investigation.
- b. The lawyers then deny representation to stop harm to me. The lawyers deny representation as directed by the US government and US military/army. It's a US government led restriction.
 - i. There is a refusal of lawyers to review the case as national policy in the US. For example I have spoken with 25-40 lawyers in Massachusetts and all refused to represent my case. The same in New York, Arizona, New York, California, and Florida (20-40 lawyers in each state).
- c. It became a way for doctors to cause harm in a unchecked way where they could cause a massive amount of harm with no repercussion. It became a national agenda- the

lawyer association of each state prevented legal help, they stated it's a felony crime in harming me, but they wouldn't represent me. **Its against a constitutional basis in the US, against the sixth amendment, which is a right to a attorney and representation.**

- d. They publicly state that it's a lawless country to me in the US, they advertise it. As I am driving my car in the US they advertised that the country is "lawless" (they make public shows in my case). They limited lawyers with the direction of the US government, making it a US government driven persecution and harm.

- b. I tried reporting it but they restricted reporting it. The police were restricted from acknowledging the case so the crime went unchecked.
- c. Then it became a US government role in causing harm to me, so it became a situation of US government persecuting me, necessitating asylum/refugee status.
- d. Its stated that it's the US governments support of Arnab Raychaudhury by misinformation by Arnab lead to the US governments persecution of me.
- e. I am not safe in any state in the US from physical harm because they use my clinical condition to do so.
 - a. I tried reporting it to the UK police through Interpol and they stated that it is not within their jurisdiction to report crimes to the US.
 - b. I tried reporting it to FBI agents in the US embassy and they wouldn't respond to it as a US agenda.
 - c. I called the federal agents and they wouldn't respond as a US agenda.
 - d. This creates a repeated and redundant system where one medical doctor that committed medical negligence is supported by the next and then next. The US then internationally directed the doctors to do so, producing a hindrance to medically treat me.
 - i. This eventually causes a progressive form of neurodegeneration that causes damage to both the brain and spinal column. Gross physical pain predominates in neurodegeneration.

1. Their intent of harm to the central nervous system is intellectual and physical disfigurement.
- e. The US didn't want to admit to the negligence that took place in the US so they have doctors abroad falsify the medical tests though the diagnostics show something entirely different.
- They have full knowledge that I have MS and they are falsifying data to not treat in the US, which they extended to foreign nations. They erased diagnostic data to hide it.
 - f. Which is why there is recorded evidence of clinicians in foreign nations either falsifying medical evidence or erasing medical evidence.

The MS medications are restricted in the US to cause physical medical.

The insurance in the US denies only MS specific medications, but all other medications are fully covered unless a US doctor prescribe the medication; the US doctors deny medical treatment through insurance.

The situation at home:

In the US from 2008 December to 2017

- I couldn't move my neck, limbs, laying down for a decade in gross physical pain.
- "Cant be a outgoing person as long as he has this gross pathology in his brain and spinal column".
- Isolated and largely bed ridden at home from 2008 to 2017. Shown below. 2017 to 2019 is abroad seeking help intermittently.
 - This is me for a decade and below is what the US is trying to hide.  - Forced restriction from sexual congress (restricted to no sex, US forced virginity; im a heterosexual/straight male for 2 decades). Im still force sexually restricted.
 - Forced digital isolation (no interaction in Facebook, Google, and other social networks like Instagram)
 - **My family has no knowledge or involvement of the situation:**
 - But since its the countries agenda against me they cant help getting a lawyer to stop the harm to me in the US. They have seen me sick at home for a decade but they are helpless to help me in the US due to a US agenda with hospital restriction. They are unaware of the agenda. They have seen me unable to move to go to the bathroom, unable to talk, unable to do complex tasks and in gross physical pain for a decade and only because the US effectively restricted me to my parents house for a decade.
 - **My aren't involved but they are parents so they think and act like parents do.** They have no knowledge of the surrounding situation. They do things like parents do with no knowledge.
 - What the US did is a methodical way of hiding my condition. The US planned social isolation from my age group to hide the condition.

The above is what the US is trying to hide.

The reason for asylum in the UK (England) first.

10. It's a US government agenda by their diagnostic fraud that extends to foreign nations.
11. Reason for asylum/refugee: Asylum is the very last situation, where you have no other options in protecting yourself, it became asylum as the only remaining option in seeking safety from the US. I first applied to asylum in the UK.

12. I gathered all the evidence for asylum and left the US, they sometimes refused to give the evidence and diagnostic data that incriminates them.

13. The asylum is about a legal basis to build safety from the United States.

UK Situation – Refugee/Asylum Foul (where a country replicates the crime of the original country of refugee from)

- i. United Kingdom replicated the situation in the US causing a asylum foul.
 1. The UK clinicians cited refugee status as a reason to physically assault me in a medical setting. Once they cite specifically refugee as the reason to physically assault me it's a crime against immigration. Once the UK government restricted police and lawyer help then it became a asylum foul.
 - a. The asylum foul is directed by the US.
 - b. US started directing foreign nations to hide their crime before asylum.

 - ii. They caused similar to internal bleeding harm and tried to hide it.
14. UK instances of assault.
- a. Anand Trip on September 24th 2019 onward directed by the US falsified medical records and mistreated my condition.
 - i. I explained that I was in England seeking asylum from the US on September 24th 2019 and since there are several instances of UK medical fraud and medical assault as directed by Dr. Anand Trip.
 - ii. The doctor falsified a SEP test (sensory evoked potential to hide the neurological condition) – the slowed nerve condition rate is hidden by the doctor while the doctor causes additional damage to the central nervous system.

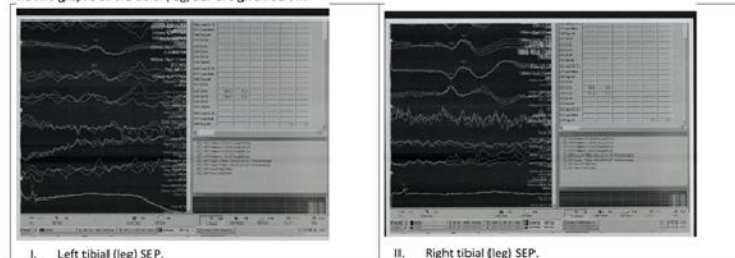

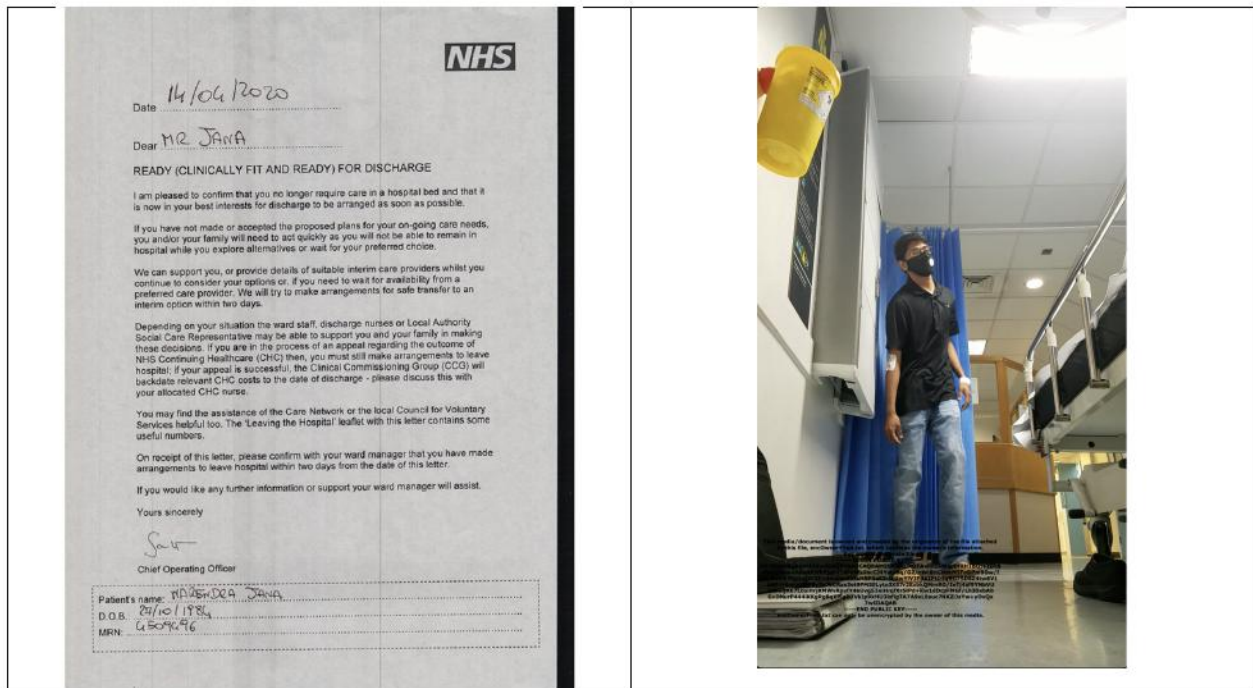

Presented with upper limb paraesthesia and sensory function of left upper limb along with reduced sensory function of left lower limb. Patient is currently undergoing treatment with 5 mg prednisolone daily and has noticed improvement in his symptoms since. Typically when flare ups occur, Mr Jais presents to Emergency departments and receives methylprednisolone IV with proceeding blood tests on an outpatient basis to cover for a 2 weeks period. Upon discussion with senior ED registrar, we advised Mr Jais that this is not normal protocol for an emergency department and the best action would be to visit his GP and be referred onto an appropriate specialist for further management for his MS. Please can GP follow up ED for further management of Mr Jais's symptoms.

- a. There are instances of doctor led assault in the UK in hospital on April 11th, April 13th and 14th.
 - i. On April 11th I went to the Addenbrookes hospital because I couldn't move my left limbs. The doctor, Dr. Alasdair Coles, refused treatment. It evolved to hemiplegia and stroke like damage. Its due to falsified tests by the doctor.
 - b. April 13th and 14th – Ambulance picked me up from home to Addenbrookes Hospital.

2. The doctors do so in an attempt to physically disfigure me as a overall agenda led by the US. Its both a immigration and a medical crime.
 - a. There were attempts at reporting the situation in Addenbrookes hospital to the police, the police denied investigation. They stated that's it's the role of the medical boards in the UK.
 - b. The General Medical Counsel and the PHSO (the medical boards) refused to investigate the case even after assault. The GMC is comprised of other medical doctors that support the doctor that committed clinical fraud and then assault.

Hello Ms. Levine,

You reviewed my case before in early January 2020 but was not sure you could take the case. Since then my case with the clinicians has evolved in a new direction that would indicate criminal intent on the part of the physicians (with evidence of criminal intent). We ended our last communication with the demonstration that the clinicians loaded some data sets to upload clinical fraud in other settings.

But the situation the clinicians has evolved in recent months (April 2020) of assault in a ER (Emergency Room/department) settings, where the patient (me) is in a severe medical state (which I recorded, hemiplegia due to a Multiple Sclerosis-relapse) and the clinicians in ER did two things (1) withheld medication in a severe clinical state while citing the false statement of the initial clinician in question and 2) falsified the clinical reports in ER with clear evidence of criminal fraud.

I reported these events to the police (which they mentioned as a form of assault). So now it would be a combination of clinic fraud and negligence in emergency situations with the intent to cause.

So, if you are willing to look at the evolved situation I could send you the recent data to see if you would be willing to take the case. The case is clearly and completely explained. With all records and negation of the records included to show what the intent of the doctors are.

Dear Mr Jana,

Thank you for your email.

I appreciate you may be disappointed with our decision not to investigate your complaint. Whilst there are some complaints that can be looked at by both us and another complaint handler, we usually take the view that only one investigation should take place. In light of the allegations you are raising and your desired outcomes we have decided it is best for the GMC to consider the whole of your complaint.

Whilst we appreciate your outstanding concerns in relation to your medical records, medical records are a legal document and if you feel they have been falsified you would need to seek legal advice regarding this issue.

If you think we have made the wrong decision, we do have a formal review process, whereby a review team looks into the decision that has been made. It is important to explain that we cannot change our decision based on disagreement alone. Instead, we would need to see evidence that we have done one or more of the following:

1. We overlooked evidence in your complaint which would lead us to change our decision;
2. We misunderstood your complaint and the evidence relating to it;
3. There is new evidence available (which we previously did not consider) which would lead us to change our decision.

<p>Dear Mr Jana</p> <p>Your concerns about Drs Trip and Catania</p> <p>Thank you for your correspondence of 5 May. I can see that you are unhappy with the outcome of your Rule 12 request regarding Dr Trip and Dr Catania. I am sorry we were unable to provide you with the outcome you were seeking. Our role as a regulator means we are bound by strict rules and we do our best to explain our decisions but we are always conscious that we often have to deliver what we know are likely to be unwelcome messages as a result of applying our various legal tests.</p> <p>I can see that you are disappointed because no action has been taken against these doctors in relation to your concerns. I should begin by explaining that the GMC is not a general complaints resolution body. Our fitness to practise procedures and powers are only engaged in response to concerns that are so serious they might call into question whether an individual doctor's right to continue to practise medicine should be restricted or removed.</p>	<p>Dear Mr/ Mrs/GMC Review,</p> <p>I would imagine that the new situation would be passed on to the image team due to the severity of the harm caused but in situations like this complaints aren't considered as separate from the original complaint. There's a tape in basic reasoning report.</p> <p>I am sure that Dr. Trip tries to withhold medication/treatment in another instance of a ER (ER) setting to physical harm, there's additive to former instances. It will always be presented as a collective case to define the collective behaviour of the physician. If another instance occurs there will be another police report that indicates assault by the physician related to former instances (its always additive and collective).</p> <p>So this would be considered a continuation of the same complaint, since the same physician perpetuating more serious instances of harm in a second setting.</p> <p>Ignoring history of why the physician perpetrated harm in the second setting doesn't make sense either, physical harm in the second instance adds weight to the first instance of physical pain. need for refugee protection from the UK and US.

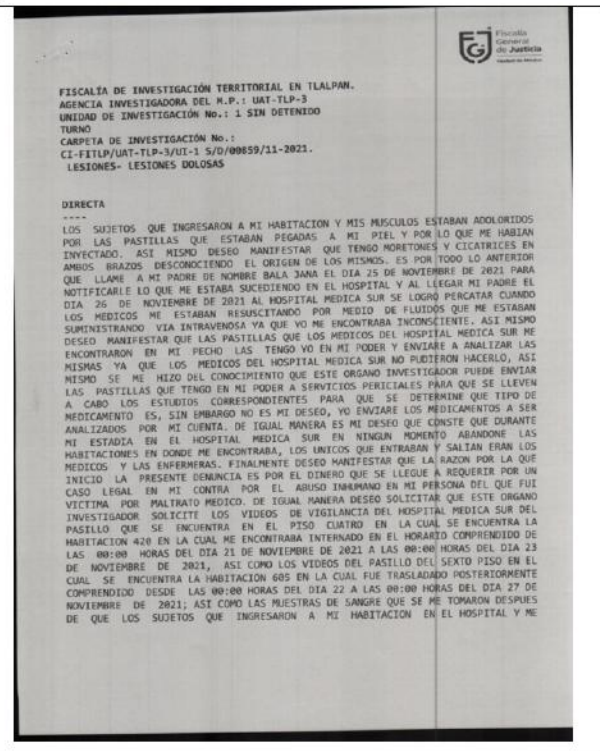
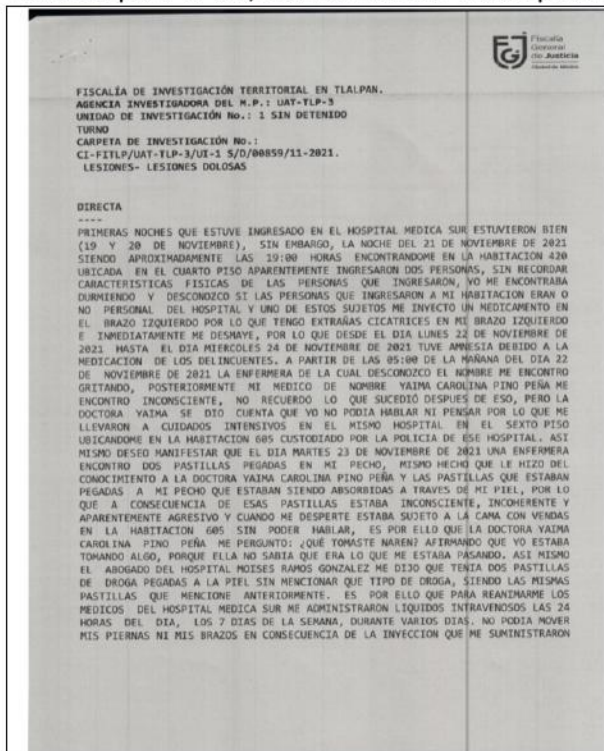
3. Why did they do it? Its because the US was afraid of admitting to the crimes that took place in the US.

US aggressively pushed me to a foreign nation, then asylum by force, with repeated denial of help in UK asylum. So I have no choice but asylum/refugee status in a different country.

Recent US military method of harm in 2021 and 2022:

Neuro verse/brain verse/neuro source/brain source:

The United States has and uses a system where they can rapidly change the neurological state of a person. Eg. they change the moods state of a person. I believe its called neuro verse/brain verse/neuro source/brain source.

From what I learned of the system it was meant to be a system for basic communication in a hidden way between people but it ended up being a system where they could commit crimes by keeping communication secret.

The system evolved as far as changing the perception of a person about a particular person or a topic. Then the communication system became a bio terrorism method. The bioterrorism pertains to how a person could have a change in perception of a physical feeling that didn't exist before.

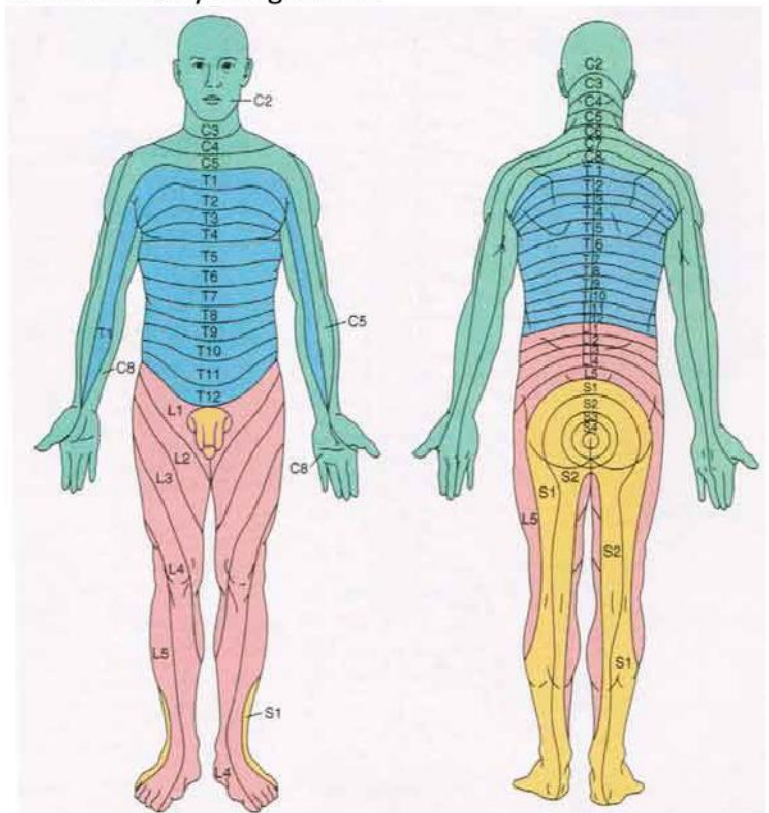

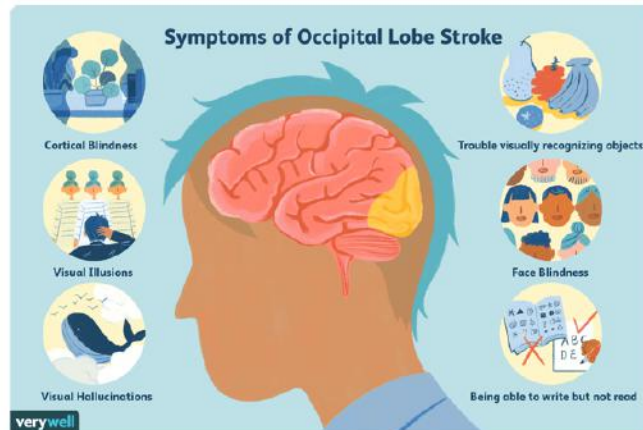
- Creating a reason for discrimination and persecution:
